




# Primary Impression by Year




# 2025 Trauma by Region – 0.68% increase from 2024




# 2025 Stroke by Region – 3.7% decrease from 2024




# 2025 STEMI by Region – 4.4% decrease from 2024



# 2025 Burn by Region – 2.9% increase from 2024




The LCC had an additional 232 of the 16,628 Pre-hospital patients for a total of **3,597** total transfer requests.




Top 2 regions

# Trauma Secondary Transfers


Directed by LERN

n = 2,014




Secondary transfers for LERN directed patients was 3% in 2021, 5% in 2022, 5% in 2023, and 4% in 2024.

Patients not directed by LCC and required transfer was 48% in 2021, 55% in 2022, 55% in 2023, and 48 % in 2024.
