In accordance with the provisions of the Administrative Procedure Act (R.S. 49:950 et. seq.), the Louisiana Emergency Response Network Board hereby announces its plan to proceed with rule-making by finalizing the February 20, 2015, Notice of Intent that was promulgated on pages 490-492 of the *Louisiana Register*.

The rule codifies the trauma destination protocol adopted by the Louisiana Emergency Response Network Board on November 20, 2014.

The Board received no comments or requests for public hearing; and therefore has not conducted a public hearing pursuant to R.S. 49:953(A)(2).

The Board has made no changes to the rule.

Subject to legislative oversight by either the House or Senate Health & Welfare Committee, the Board intends to submit a Rule to the Office of the State Register for publication.
