In accordance with the provisions of the Administrative Procedure Act (R.S. 49:950 et. seq.), the Louisiana Emergency Response Network Board hereby announces its plan to proceed with rule-making by finalizing the August 20, 2016, Notice of Intent that was promulgated on pages 1399-1401 of the *Louisiana Register*, Vol. 42, No. 08.

The rule codifies the trauma program recognition adopted by the Louisiana Emergency Response Network Board at its meeting of May 19, 2016.

The Board received no comments or requests for public hearing; and therefore has not conducted a public hearing pursuant to R.S. 49:953(A)(2).

The Board has made no changes to the rule.

Subject to legislative oversight by either the House or Senate Health & Welfare Committee, the Board intends to submit a Rule to the Office of the State Register for publication.
