PUBLIC HEARING PROCEDURES

- A. This hearing is being recorded so that all comments can be fully considered.
- B. Everyone who wishes to speak shall have the opportunity to do so.
- C. Every person wanting to speak must fill out a request slip (Attachment #2)
 - a. If you have not already done so, please fill out a slip now.
 - b. If you need slip, please raise your hand and a slip will be provided to you.
- D. Limitation on Time
 - a. Speakers will be limited to 10 minutes, unless the presiding officer determines that the time needs to be reduced or increased. Time will be reduced if the speaker is merely repeating what he has already said. Time will be increased if the comments are productive and are not repetitive.
 - b. A speaker is to state:
 - i. Whether he or she is for or against the proposed rule or any of the amendments being proposed.
 - ii. Specific provisions being commented on;
 - iii. The specific reasons for the speaker's position; and/or
 - iv. Any recommendations by the speaker regarding the amendments.
 - c. A speaker who starts to repeat himself or herself will be asked to move on to any other comments.
 - d. A speaker who merely states that he or she is against the proposed rule and/or any amendments or any part of the amendments but does not provide specific reasons for doing so, may be asked to supply specific reasons for the position.
- E. Discussion of matters unrelated to the amendment will not be allowed.
- F. No response to the comments or submissions will be made today. As stated earlier, all comments and submissions will be fully considered before any response is made.
